Licensed pest control applicators affiliated with a CVR MLS Service Provider Company are eligible for Limited Access eKEY service subject to completion of the required applications and payment of the one-time activation fee and monthly SUPRA subscription fee. The annual fee for a CVR MLS Service Provider Company is based upon the number of licensed pest control applicators affiliated with the Company up to a maximum fee of \$2500.

Annual fees are calculated and billed electronically on June 1 for the billing year July 1 through June 30. The fee due at the time of application will be prorated based upon the number of months remaining in the billing cycle.

Annual and prorated fees are non-refundable.
